QUALITATIVE AND QUANTITATIVE COMPOSITION:

Each anti-reflux technology capsule of **FORTALINE® PLUS** contains 500 mg of fish oil with 30 % of essential omega 3 fatty acids (standardized to 18% EPA and 12% DHA) and 10 mg of Vit E. EnteriCare™ Anti-Reflux Technology capsules: non-coated and transparent softgel, made of GRAS Pectin. The EnteriCare™ technology reduces the risk of reflux and enables to avoid a fishy aftertaste.

PHARMACEUTICAL FORM: Blister strip package of 20 capsules.

CLINICAL PROPERTIES: Contraindications: **FORTALINE® PLUS** capsules are contraindicated in people who are hypersensitive to any of the ingredients of the product.

Special warnings and precautions for use: Since fish oils are derived from marine life, allergic reactions are possible. The using of the product must be stopped if rash or other allergic reaction is observed. You are immediately advised to consult your physician. If you are going to have elective surgery, you may need to stop taking this supplement before the procedure. Let your health care professional know you are taking fish oil prior to scheduling the surgery.

Interactions with other medicinal products: The only interactions omega 3 fatty acids are likely to have are with anti-coagulants and possibly aspirin, where it can in theory enhance the reduction in blood viscosity.

Pregnancy and lactation: **FORTALINE® PLUS** is beneficial for pregnant & nursing mothers and is also an excellent nutritional choice for women who are actively trying-to-conceive. Scientific studies indicate that pregnant and breastfeeding mothers do not receive sufficient omega 3 fatty acids in their diets.

Undesirable effects: Side effects that you should report to your doctor or health care professional as soon as possible: mood changes or emotions, easy bruising, skin rash or unusual skin reaction. Side effects that usually do not require medical attention (report to your doctor or health care professional if they continue or are bothersome): bad breath (fishy breath), belching, diarrhea, heartburn, nausea, stomach upset and weight gain.

Overdose: In case of overdose, there is no particular recommendation. A symptomatic treatment should be initiated.

SPECIAL PRECAUTIONS FOR STORAGE: Store below 30 °C, in the original package, protected from humidity. Keep out of reach and sight of children. Do not use after the expiry date, stated on the packaging (Exp). The expiry date refers to the last day of that month.
